- 5 A 'fit and proper person' is a legal category of personhood in Britain, first used in seventeenth century to assess a man named Lascelles in order to ascertain capability for owning slaves.
- 6 In our previous ethnography 'couple culture' was named as the most excluding for of social organization, much more pernicious in securing adjustment to the normation than ideologies of domesticity and motherhood (Skeggs 1997).

- 9 We contrast this working class form of survival with the genre of entertainment called 'extreme sports' where usually upper and middle class men, such as Ranulph Fierrand Bear Grylls, purposefully put themselves in extreme conditions in order to display how supposedly clever they are: survival as spectacular sport and adventure rather than everyday reality.
