

In migration matters, Colombia, by normative literalism and constitutional doctrine, is bound to follow patterns of reinforced protection functionally related to the constitutionalisation of migration, and to the interpretative and applicative results that emerge from the delegation of legal sovereignty in the regional or inter-American system of human rights, but it is also equally bound by extensive relative bindingness more favourable to migrants in other conditions of normative inference, in the scenario of interpretation and application under the competences of the ECtHR in this matters of human essence. It is important to add that the above commitment is also understood as integrated with the globalisation of migration as a fundamental station of universalisation *pro homine*, in what we would call global migration law.

In this field of protection, the legal ostension does not depend on the strong and cohesive implementation of the migratory law of local and regional origin in Europe or in America by way of integration, but of its universality. Thus, as the Colombian Constitutional Court says: "the compass of the European mechanisms covers American territories. It is a good time to return to the starting point: The Universal character of Human Rights."
