

SELECT BIBLIOGRAPHY

The bibliography is divided into three parts. The first section lists works by Ricoeur quoted in the text. References are made to the editions consulted (usually the English edition if readily available) and listed in alphabetical order. The original publication date, when different, is given in square brackets; the date is preceded by "Fr" if it indicates the original French edition. For an exhaustive bibliography of Ricoeur's writings and their original sources, see the entries under Vansina and Lapointe in the second section which lists works about Ricoeur. For an extensive bibliography of this secondary literature, see Lapointe, "Paul Ricoeur and his Critics." The final section lists other works consulted in this study.
