# Insurance Block Exemption Regulation: EU Commission challenges statistics and co-(re)insurance exemptions 261

A European Commission report threatens the continued existence of the Insurance Block Exemption Regulation ("IBER"). The regulation protects essential industry practices, namely the sharing of statistics and certain joint insurance arrangements (line slips, pools, consortia, joint binding authorities). The report invites the sector to explain why the regulation should not lapse, without renewal, when it comes to an end in 2017. The report appears to be based on partial data and misunderstands key features of the industry. So it will be important for stakeholders to respond robustly to the report's conclusions. The loss of this protection—especially on flawed grounds—creates potentially damaging legal uncertainty.

# Extradition discrimination? Pisciotti's legal battle continues as Regional Court of Berlin refers questions of fundamental EU law principles to the CJEU 277

In the legal battle of the alleged marine-hoses-cartel participant, Mr Romano Pisciotti, the Regional Court of Berlin has referred specific questions to the CJEU for preliminary ruling. The referral order calls into question the current extradition practice of many EU Member States and provides the CJEU with the possibility to further clarify the fundamental EU principle of non-discrimination. In addition, it touches on delicate issues in EU-US extradition cases and will be of particular interest with regard to future extradition requests based on antitrust charges.
