This main intent of the new UK fines guidelines issued by the OFT in September 2012 is to increase the levels of fines for serious competition law infringements, but recent CAT judgments have also forced the OFT to give greater consideration to proportionality. This article argues that this pressure for fines to be proportionate to the offence will constrain the OFT to place more weight on the economic effects of infringements, and that doing so will give greater legitimacy to penalty awards and improve the UK enforcement regime.

The adoption of new Fining Guidelines is a further step in the development of Belgium's national competition law and creates a more transparent and secure enforcement environment.
