Under Pressure — when do legal "recommended" resale prices turn into illegal "fixed" and binding resale prices: Resale price maintenance under scrutiny in Germany 317

This article addresses the legal framework of resale price maintenance (RPM) under EU and German competition law. It highlights the circumstances under which legal "recommended" resale prices might amount to illegal "fixed" and binding resale prices. In particular, it will analyse which kind of exertion of pressure may turn a legal "recommended" resale price into an illegal "binding" resale. In its final remarks, the article draws the attention to the fact that RPM is not only an enforcement priority in Germany, but also in a number of EU and non-EU countries where heavy fines were also imposed on a number of companies in diverse industry sectors.

Supreme Court of Canada establishes that specific authorisation is needed for computer searches in Canada — will the European Union follow this lead? 322

This article assesses the *R v Vu* decision by the Supreme Court of Canada, and explains the current policy of Canada's Competition Bureau when searching computers, comparing its role to that of Commission investigators, and asks whether unauthorised computer searches in the European Union could ultimately be challenged under the European Convention on Human Rights.
