Italian Torpedoes in the shadow of the Recast Brussels Regulation 2012 263

On January 10, 2015, a new Recast Brussels Regulation will come into force, bringing a number of important reforms designed to improve and harmonise rules on intra-European commercial litigation. This article focuses on the reform to the *lis pendens* rule under art.31 and the extent to which it has resolved the problems posed by the so-called Italian Torpedoes. Tactical litigation has been at the centre of the Brussels regime since its founding, despite attempts by national courts to curb this practice in support of choice of court agreements. Despite the reform, we find potential for tactical litigation under the Recast Regulation through the related action route.

The Romanian Competition Council (RCC) made a step forward, sanctioning for the first time an anti-competitive horizontal agreement in the form of a collective boycott aiming to exclude a competitor from the market. The RCC's extensive reasoning with focus on the media services market includes novelty elements in terms of the infringement assessment and individualisation of fines that are worth being considered.
