This article explores the implications of the UK's Office of Fair Trading *Reckitt Benckiser Healthcare* case against the backdrop of the EU's Sector Inquiry into the pharmaceutical sector and the controversy surrounding the interface between competition law and intellectual property law. The article concludes with some alternate approaches that may, when used collectively, reduce the ability of pharmaceutical companies to extend the duration of patent protection.

Turkey: Turkish Competition Board refused to launch investigation into certain practices of Google 64

The Turkish Competition Board refused to initiate a fully-fledged investigation against Google. The complaint against Google was mostly based on the allegation that Google is the dominant player in the market for search engines and leveraged its market power in the market for search engines into the online advertising services through tying and bundling practices and its rebate system. This decision can be appealed before the administrative courts.
