Index extracts from them, plus some decisions as to admissibility or extracts from the 887
Many judgments and most decisions as to admissibility are not published in the official reports.

From 1996 to 1998 these official reports covered both the Commission and the Court; from 1999 they cover only the Court, following the demise of the Commission. The annual volumes are published as separate parts. The judgments and decisions are published in English and French. Citations indicate the volume and part, but not the page number within the volume. Eg. *Khan v UK* 2000-V. There is no equivalent to the Series B reports.

Of great importance is the Court's HUDOC database, to be found on the Council of Europe website: <http://www.echr.coe.int/echr/>. HUDOC has all the recent Court judgments and admissibility decisions, whether they are printed later in the official reports or not. Judgments in HUDOC are cited as follows: *Ploski v Poland* hudoc (2002). Decisions as to admissibility are cited as follows: *Gonzalez v Spain No 43544/98* hudoc (1999) DA. DA is added to assist in finding the case in HUDOC. HUDOC judgments are in English and French or, in the case of less important cases, English or French.

Some report series are specific to the former European Commission of Human Rights:

Collection of Decisions of the European Commission of Human Rights.

This series (volumes 1-46, 1959-1974) was published by the Council of Europe in English and French. These are cited as follows: *X v Norway No 867/60* 6 CD 24 1961.

Decisions and Reports of the European Commission of Human Rights.

This series (volumes 1-94, 1975-1998) was published by the Council of Europe. It contains in English and French selected Commission decisions as to admissibility; Commission friendly settlement reports; and Commission reports on the merits under the former Article 31 of the Convention when the case was not referred to the Court. In the case of an Article 31 report, the Committee of Ministers resolution is also printed. As of 1999, the volumes are published as volumes 76-A and 76-B, etc, with volume A containing the original language of the decision, etc, and volume B containing the translation.
