Alberto Ardèvol-Abreu is Associate Professor in the Department of Communication Sciences and Social Work at the University of La Laguna. His research focuses on the implications of new media-related phenomena for democracy and political participation. His articles cover various aspects, including conspiracy beliefs, disinformation, citizen journalism, political polarization, and political discussion. He has received important recognition for his work, including the best article award on politics and information technologies from the American Political Science Association, the Robert M. Worcester Award from the World Association for Public Opinion Research, and the Oregio Laguna 2013-2017 Award for the most cited article in five years.

Natalia Aruguete holds a PhD from La Universidad Nacional de Quilmes (UNQ). She is a professor at the Universidad Nacional de Quilmes and the Universidad Austral, and a member of CONICET (Argentina's Federal Agency for the development of Science and Technology). She has published four books and fifty articles studying the relationship between traditional media and social media, with particular attention to the effect of political agendas, media agendas, and the public. Her last book is *Plata es contra ellos. ¿Cómo trabajan las redes para confirmar nuestros creencias y rechazar las de los otros?* (Siglo XXI Editores).
